ADDITIONAL RULES

- 1. No entry may be changed or canceled unless notice of the change or cancellation is received in writing or by telegram by the Superintendent or Show Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made in the sex of a dog, or a dog may be transferred from one division of the Puppy Class to another or between the Puppy and Twelve-to-Eighteen Month Class at a show prior to the judging, and except that dogs which according to their owners' records have completed the requirements for a championship after the closing of entries for a show but whose championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed or Variety competition, provided this transfer is made by the Superintendent or Show Secretary at least one half-hour prior to the scheduled start of any regular conformation judging at the show. No dog may otherwise be transferred to another class. Owners are responsible for errors in the entry forms, regardless of who may make such errors. AKC Rule, Ch. 11, Sect. 6.
- 2. A \$3.00 AKC Event Service Fee & AKC Recording Fee of \$.50 will be required for each dog at any licensed or member club show, obedience trial, rally trial or tracking test. These event service fees and recording fees are to be collected by the show giving club and paid to the AKC. If a dog is entered in more than one class in the show, these Recording Fees are to be collected on the first entry only. AKC Rule, Ch. 11, Sect. 2.
- 3. Returned checks do not constitute a valid entry fee. There will be a \$15.00 collection fee added to the amount of each returned check.
- 4. During the hours of judging, owners are to be on call, and to have their dogs ready to bring into the judging ring promptly. Dogs need only to be present for their judging. Dogs not needed for further judging may be excused. The Club is not obligated to provide any service for notifying exhibitors of judging.
- 5. If it is impossible to open or to complete the show because of riots, civil disturbances, or other acts beyond the control of the management, no refund of entry fee(s) will be made.
- 6. There is no provision for unentered dogs at the show. AKC Rule Ch. 11, Sect. 11.
- 7. There will be NO exercise pens, crates, tents, or grooming tables allowed within ten (10) feet of the judging ring. All grooming must be done in areas specified by the club and exhibitors are required to keep their areas clean.
- 8. All trophies must be claimed the day of the show. None will be mailed.
- 9. This Club and its show secretary assumes no responsibility for wrong or incomplete information given on the entry form by the owner or agent for the owner, nor for the owner or owner's agent entering a dog in a class in which it is not eligible to compete, or for entering the same dog twice.
- 10. Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the veterinarian or judge, barred from competition by action of the Bench Show Committee, or because the dog is ineligible to compete due to being entered incorrectly. There is no refund of entry fee for duplicate entry.
- 11. The Club and/or its show secretary will NOT be responsible for the loss of, or damage to any dog exhibited, whether the result of accident or other causes and in addition assumes no responsibility for any loss, damage, or injury sustained by any exhibitor or handler. <u>Novice Junior Class:</u> For Boys and Girls who are at least 9 years old and under 12 years old on the day of the show and who, at the time entries close, have not won three first place awards with competition present in the Novice Class at a licensed or member show.

<u>Novice Intermediate Class:</u> For Boys and Girls who are at least 12 years old and under 15 years old on the day of the show and who, at the time entries close, have not won three first place awards with competition present in the Novice Class at a licensed or member show.

<u>Novice Senior Class:</u> For Boys and Girls who are at least 15 years old and under 18 years old on the day of the show and who, at the time entries close, have not won three first place awards with competition present in the Novice Class at a licensed or member show.

<u>Open Junior Class:</u> For Boys and Girls who are at least 9 years old and under 12 years old on the day of the show and who, at the time entries close, have won three first place awards with competition present in the Novice Class at a licensed or member show.

<u>Open Intermediate Class:</u> For Boys and Girls who are at least 12 years old and under 15 years old on the day of the show and who, at the time entries close, have won three first place awards with competition present in the Novice Class at a licensed or member show.

Open Senior Class: For Boys and Girls who are at least 15 years old and under 18 years old on the day of the show and who, at the time entries close, have won three first place awards with competition present in the Novice Class at a licensed or member show.

The winner of the Novice Class shall automatically become eligible, upon notice to the Open Class ring steward, to enter and compete in the Open Class at the same show provided the win is the third (3rd) first place award with competition and further providing there are one or more Junior Handlers competing in the Open Class.

Each dog handled in a regular Junior Showmanship Class must be entered in one of the breed classes at this show or entered for Junior Showmanship only. However, a dog that must be withdrawn for good and sufficient reason, such as a bitch in season, or a veterinarian's excuse, may be replaced by another dog meeting the below ownership requirements. Such substitution must be required in writing stating the reason for the substitution and must be accompanied by an official AKC Form. All such requests must be made at least one half hour prior to the judging of any regular class at the show.

Each dog must be owned by the Junior Handler or the Junior Handler's father, mother, brother, sister, uncle, aunt, grandfather, or grandmother, including the corresponding step and half relations. Every dog entered in Junior Showmanship must be eligible to compete in Dog Shows or Obedience Trials. BITCHES IN SEASON ARE NOT ELIGIBLE. At a specialty show, each dog must be of the breed for which the show is held.
